Release & Indemnity Agreement**

**Please complete a form for each person listed on your application.**

**Release:**

You have voluntarily joined the BMW Riders of Knoxville (hereafter referred to as the "Club"). In consideration of the opportunity to participate in any event, including meetings which are sponsored by and/or conducted in part by the Club, its officers and members, hereafter referred to as the "RELEASED PARTIES", I on my own behalf and on behalf of my participating family members, our heirs, personal representatives, successors and assigns, hereby release and hold harmless the RELEASED PARTIES from any and all claims, demand, rights and causes of action of any kind whatsoever which I/we have now or may later have against the RELEASED PARTIES in any way resulting from, arising out of or in connection with the performance and/or involvement with any such event and/or from any claim that may arise from my/our participation in any event. On various occasions, the Club will sponsor riding events. This does not indicate that the facilities or course have been inspected or approved by the Club, nor does it indicate that Club members or officers have been trained or accredited by the Club, nor does it indicate that your safety has been warranted by any Club authority.

This release applies to any kind of situation, whether it relates to negligence, conditions, instructions, rules or procedures related to the event.

**I UNDERSTAND THAT BY SIGNING THIS, I AGREE THAT I WILL NOT SUE ANY OR ALL OF THE RELEASED PARTIES FOR ANY INJURY THAT MIGHT RESULT TO ME OR MY PROPERTY ARISING FROM OR IN CONNECTION WITH THE PERFORMANCE OF ANYTHING ASSOCIATED OR CONNECTED WITH THE SPONSORING, PLANNING OR CONDUCTING OF THE EVENT.**

To some extent, all motor vehicles are inherently dangerous. You should take part in any of the Club events based on your own assessment of your abilities. Club events may traverse public highways and the Club is not responsible for their condition or the action of other individuals using the public highways. The Club urges you to wear a helmet and other appropriate safety apparel. The Club also urges you to receive professional instruction before operating a motorcycle and to carry proper insurance coverage. The Club does not provide medical insurance. The Club urges you not to operate a motorcycle without personal medical coverage.

**Indemnity:**

Despite this release agreement and covenant, if I, or anyone on my behalf, make any claim against any of the RELEASED PARTIES, I agree to indemnify and hold harmless the RELEASED PARTIES from any and all claim and litigation expenses, attorney's fees, loss, liability, damage or cost that they may incur due to the claim brought against them. This means that I will be responsible for seeing that these expenses get paid. I further agree to waive any rights that I may have by Tennessee state law which might limit or void the scope and/or effect of this release and indemnification agreement.
